- ee. Mr. Boyer was appointed **Voting Delegate to the PSATS Convention** on a motion by Supervisor King and seconded by Mr. Guise. The motion carried.
- 8. The pay scale for appointed positions, road workers, and laborers will have an increase of 4% "across the board", with the exception of Roadmaster Charles King, on a motion by Mr. Boyer and seconded by Mr. Guise. The motion carried. Mr. Boyer then made a motion to increase Roadmaster Charles King by 4%. Mr. Guise seconded the motion. Supervisor King abstained. - 9. Mr. Boyer made a motion to recommend to the Auditors to pay the same **mileage rate** as the Federal rate, which is now \$0.67. Mr. Guise seconded the motion, and it carried.
- 10. The Supervisors will recommend to the Auditors a **Bond Rate** of \$1,400,000.00, which includes the ARPA fund, on a motion by Mr. Boyer and seconded by Mr. Guise. The motion carried.
- 11. Supervisors will continue to hold their regular business meetings on the second Thursday of every month at 7:00 PM at the Municipal Building at 750 Trolley Road, York Springs, Pa. on a motion by Mr. Boyer and seconded by Mr. Guise. The motion carried. The actual meeting dates will be posted on the Website and the Municipal Building front door bulletin board, and advertised in the Gettysburg Times.

The Head Roadmaster and Assistant Roadmaster also have the New Year's Day holiday with eight hours of pay, and November Election Day. Supervisor King seconded the motion and it carried.
- 14. Adams County National Bank and Members First Federal Credit Union will be the **depositories** on a motion by supervisor King and seconded by Mr. Boyer. The motion carried.
- 15. York Adams Tax Bureau will collect the **Earned Income Tax** on a motion by Mr. Boyer and seconded by Supervisor King. The motion carried.
- 16. Karen Heflin, the Recorder of Deeds at the Adams County Courthouse, will collect the Real Estate Transfer Tax on a motion by Mr. Boyer and seconded by Mr. Guise. The motion carried.
- 17. **Equipment rental fees** include the operator and will be increased as follows: Dump Trucks, Grader, Pay loader, and the Tractor at \$100.00 per hour, this will also include the Backhoe which is being added to the list.
