### **○**CALL THE MEETING TO ORDER

The regularly scheduled meeting of the Huntington Township Board of Supervisors was called to order at 7:00 PM by Chairman Paul Guise with Supervisor Jeff King present. Supervisor Mark Leer was absent. Mr. Guise announced that the meeting was being recorded. Please speak clearly. Only one speaker at a time.

### PLEDGE OF ALLEGIANCE

Mr. Guise led us in the Pledge of Allegiance.

### MOMENT OF SILENCE

Everyone present observed a Moment of Silence.

PUBLIC PARTICIPATION FOR AGENDA ITEMS There were no comments.

### SECRETARY/TREASURER'S REPORT

- Approve June 8, 2023, BOS Meeting Minutes The draft minutes of the June 8, 2023, meeting were previously distributed to the Supervisors for their review. Mr. Guise made a motion to approve the minutes as distributed. Supervisor King seconded the motion and it carried.
- Approve the Bill List for July 13, 2023 The Bill List for July 13, 2023, was previously distributed to the Supervisors for their review. The General Fund bills amounted to \$35,257.53. There were no State Fund bills. The American Rescue Plan Fund bills were \$200.00. Total of all expenditures was \$35,457.53. Mr. Guise made a motion to approve the Bill List as distributed. Supervisor King seconded the motion and it carried.
- 3. Acknowledge the Financial Report for July 13, 2023 Mrs. Davis read the Financial Report for July 13, 2023. The General Fund has a balance of \$926,945.88. The American Rescue Plan Fund has a balance of \$251,303.91. The State Fund has a balance of \$228,478.99. Total of all accounts as of July 13, 2023, is \$1,406,728.78. The Supervisors acknowledged the Financial Report for July 13, 2023. Elizabeth Hower asked where the General Fund income comes from. This month \$43,436.07 was Local Earned Income Tax, (1.7% of the gross wage) withheld from actively employed residents of our Township. Earned Income Tax is not paid by retirees. The remainder was a combination of permits, interest, and other sources.
- 4. Miscellaneous Items a. The Holy Trinity Lutheran Church in York Springs will hold a Book Fair on August 26<sup>th</sup> from 10:00 AM until 2:00 PM. "Free books for children of all ages". b. ACTPO meeting will be held July 26<sup>th</sup>, from 1:00 until 3:00 PM. c. COSTARS is waiving the 60% minimum purchase of antiskid for the 2022-2023 season due to the mild winter. We did purchase our 60%.

### - ROADMASTER'S REPORT

Road Foreman Chuck King reported the road crew has completed the second round of mowing and trimming.

Russell Standard has the tar and chip project scheduled for August 7th. No word from Wilson for Oxford Road.

### **ZONING OFFICER'S REPORT**

Mr. Fridenvalds has issued the following permits since the June 8, 2023 meeting: Scott Gaines — an addition; Ben Smyers — replace deck; John Fready — single story ranch house with attached garage; Mike Megonnell — roof top solar; Tammy Chestnut — inground pool; Stephen and Karen Levan — single story dwelling w/2 car garage; John Gay — rooftop solar; and Brian Stump — 2 story addition.

Rusty Ryan from ACOPD came to discuss two complaints. The first was for the Stormwater Plan for 7250 Old Harrisburg Road. The other was for the sheds on Old Harrisburg Road, which Mr. Ryan believed to be in the State Right-of-Way.

Mr. Ryan also pointed out that the State Game Commission is building a parking lot on Route 94 and they do not have a permit.

Mr. Fridenvalds had a complaint about a dumpster on a street in Flowing Springs. He gave them a week to move it.

SamWill Acres and Christopher and Heather Miller were charged with violating our ordinances and building codes. There were two hearings and they lost both. They appealed both dockets in County Court, and now they are asking for a continuance.

### SOLICITOR'S REPORT

Solicitor King had a spread sheet showing missed trash pick-ups by Waste Management. He is working on a way to collect liquidated damages.

### **ENGINEER'S REPORT**

Engineer Longstreth presented the following report:

- 1. Greenbriar Road Culvert Replacement- He received three proposals for geotechnical investigations, from Triad, ECS, and FTG. The Supervisors will discuss this later on the agenda.
- 2. Mr. Longstreth is looking into a possible funding source through PADEP, ACCD, and the Dirt, Gravel, and Love Volume Roads Program.
- 3. The speed study for Orchard View Road, Rolling Road, and Starner Station Road is ready to be performed.
- 4. The Myerstown Road Culvert project is on the schedule to be surveyed.

### FIRE COMPANY REPORTS

York Springs and Heidlersburg Companies submitted their call reports for the month of June.
